CONTRACT TERMS:

1. This estimate has been prepared based on your requirement. So kindly go through the Time Estimate in detail and get in touch for any clarifications or modifications that may be required.
2. Any additional requirement will be estimated as per actuals and billed against the mentioned hourly rate.
3. All hours will be logged along with the time sheet on a weekly basis.
4. Payment Terms:
 - a. Upon signing the contract, 20 % of the net cost should be paid towards advance.
 - b. Billing will be done against weekly time sheet and payment intervals will be every 15 Days (2 weeks)
 - c. More that 30 Days billing due may affect the continuity of the development time. In due cases the ideal period will be charged at a standard billing of \$ 50 per day.
 - d. All Payments will be transferred to Comlab bank account directly. Details of the bank account will be available on the contract.
5. Duration of completion will be strictly followed as per the contract. Any additional hours spent, will not be charged by comlab. Extra duration above the stipulated time will be borne by comlab. At the same time if there is any new requirement which is not mentioned in the estimate will be charged extra as per the new hours estimated for the same with the written consent from both sides.
6. Maintenance & Updates: Post Development, first 3 months support, maintenance and updates will not carry any cost and will be treated as discount as mentioned in the estimate above.
7. Work Timings: Development Activity will be between 10.00 hrs to 18.00 hrs IST Monday to Saturday. Client discussion and support will be available between 18.00 hrs to 22.00 hrs IST
8. Additional Costs: Third Party API's, Templates, hosting and server deployment with support will be extra as per the actuals.
